Fun and inviting cross country courses complete with start box, finish flags, well built fences, appropriate questions and terrain – all correctly flagged and timed. All divisions will be offered throughout the day (8:00am – 7:00pm) – winners complete the course closest to optimum time. Feel free to enter two levels; shared horses no problem. If you had so much fun (or a lousy run) you can add a second trip if time allows. **Entries** are \$50 per rider, \$30 per rider in a pair, \$25 for a second unpinned run. Entry forms are available on our website.

Elementary 18” to 2' 275 MPM – logs, tiny table, tiny coop, slight hilliness. If a jump is fully 2' it will be flagged to allow you to choose a simple log next to it. Trainer input while on course is permitted as necessary.

Beginner Novice 2'6” 350 MPM – some terrain, small ditch, step, good variety of solid fences, water option

Novice 2'11” 350 MPM – lots of terrain, ditch, step, good variety of solid fences, water

Training 3'3” 450 MPM – lots of terrain, ditch, steps, water, new cordwood and ramp, good variety of solid fences, appropriate questions

Training/Prelim 3'6” 500 MPM – lots of terrain, ditch, water, skinnies, bounce steps, new prelim height table, mixture of prelim and training questions set at both heights
